(a) Purpose of Collaboration: The primary objective of this collaboration is to strengthen the academic and research capabilities of both institutions through joint initiatives, resource sharing, and the exchange of knowledge and expertise.

(b) Areas of Collaboration: Both parties agree to explore collaboration opportunities in the following areas:

- ❖ Collaborative Events
- ❖ Joint Research Activities
- ❖ Any other academic endeavor that augments the students and faculty skills and capability as mutually agreed upon.

(C) Roles and Responsibilities:**1st Partner College: Government Post Graduation College for Women-Rohtak will:**

- ❖ Collaborate with Pt. Neki Ram Sharma Government College-Rohtak on joint research initiatives.
- ❖ Facilitate the exchange of students and faculty for academic purposes in the form of Extension Lectures.
- ❖ Share academic resources and expertise.

2nd Partner College Pt. Neki Ram Sharma Government College-Rohtak will:

- ❖ Collaborate with Govt. Post Graduation College for Women, Rohtak on joint research initiatives.
- ❖ Facilitate the exchange of students and faculty for academic purposes.
- ❖ Share academic resources and expertise.

(c) Student Exchange Program: Both institutions agree to establish a student exchange program to promote cultural diversity, broaden academic perspectives, and enhance the overall development of students.

(d) Financial Agreement: Any Co-operation under this MoU is subject to the availability of the funding sources and approval by relevant authorities. Any Specific project of joint interest will be detailed in separate agreement, including financial and program specific arrangements.

(e) Duration of the MOU: This MoU will become effective on 01 Oct., 2024 and will remain in force for an initial period of Two Years (i.e. 2024-25 to 2025-26), with the option for renewal upon mutual agreement.

(f) Review and Amendment: The parties agree to review and, if necessary, amend this MoU annually to reflect changes in objectives, priorities, or other relevant factors.

This MoU represents the understanding between Government Post Graduation College for Women, Rohtak and Pt. Neki Ram Sharma Govt. College, Rohtak and is not legally bound. It serves as a framework for future collaboration, and specific projects and initiatives may be documented in separate agreements as per mutual consent of both the colleges.

MEMORANDUM OF UNDERSTANDING

Pt. Neki Ram Sharma Govt. College, Rohtak provides quality education of Post Graduate, Graduate and Honors level to both boys and girls. This College was established as Govt. Intermediate College in 1927. It was upgraded to a Govt. Degree College in 1944. The administrative control of this College was taken over by Maharshi Dayanand University, Rohtak in July 1980. The College was named as University College, Rohtak. The Haryana State Government took back the administrative control of this College in April 2006. Now this College is known as Pandit Neki Ram Sharma Government College, Rohtak. The College has made a steady progress in academic, cultural and intellectual fields. Hereafter referred to as the "FIRST PARTY".

And

Ujala Foundation is a private registered Trust with Dr. Aarti Sahu, MBBS, DGO (Gold Medalist) as its President. It came into being on 15th September, 2023 vide Regn. No. HR/2023/0372386. The main goal of the Trust is to raise awareness regarding Women's Health issues and to empower women by educating them about their Sexual and Reproductive Health and Rights. The Trust also imparts soft skills to women and young adults and also promotes legal and financial literacy.

Hereafter referred as the "SECOND PARTY", in the MOU.

In the interest of establishing a relationship of mutual benefit to both organizations, PANDIT NEKI RAM SHARMA GOVT. COLLEGE, ROHTAK and Ujala Foundation have agreed to the areas of collaboration on TRAINING related activities as mentioned in this MoU.

Objectives:

RAISING AWARENESS ABOUT WOMENS HEALTH ISSUES ESPECIALLY SEXUAL & REPRODUCTIVE HEALTH.

1. Provide Quality Sexuality Education to Adolescents, Young Adults and their parents through Educational Institutions, Workshops, Social Media etc.
2. Raising awareness about contraception among women and offering couple oriented dedicated contraception clinic.
3. Prevention of Sexually transmitted diseases.

4. Promote safe and planned motherhood.
5. Providing quality antenatal care and referral services to women with special emphasis on role of nutrition during Pregnancy.
6. Offering Post Partum Services and promoting breastfeeding.
7. Addressing myths, Taboos and Superstitions Prevalent in the society regarding women about menstruation, Infertility, Virginity, Hymen, etc.
8. Raising awareness about Feminine Hygiene, Menstrual Hygiene.
9. Educating about Menstrual Disorders like Dysmenorrhoea, premenstrual syndrome, polycystic ovarian disease etc.
10. To spread awareness about cervical cancer and vaccination to prevent it.
11. Spreading awareness about Mental Health Problems in women especially postpartum depression.
12. Spreading awareness about Menopause and addressing health issues in Postmenopausal women.
13. Education about the importance and Impact of Exercise on Women's Health.
14. Addressing the Sexual Health Problems of LGBTQ and Transgender Communities.

RAISE AWARENESS REGARDING SEXUAL AND REPRODUCTIVE RIGHTS OF WOMEN :

1. Educate Women regarding their Sexual and Reproductive Rights.
2. Raising Awareness regarding prevention of sexual and domestic violence.
3. Provide support to victims of Sexual Abuse/Violence/Harassment.
4. Provide support to victims of domestic violence.
5. Providing help to reach appropriate authorities in instances of domestic Or Sexual Violence.
6. Prevention of Female circumcision and Genital Mutilation.
7. To promote gender equality and raise awareness regarding gender based discrimination/Gender Inequality and prevent it.

8. To raise awareness regarding antenatal sex determination of Fetus and Malpractices like taking drugs to promote sex selection.
9. To raise awareness about the rights of LGBTQ community and promote a culture of Inclusion of people with different sexual Identity and orientation.
10. To spread awareness about the rights of transgender population.

COUNSELLING SERVICES :

1. To promote gender Neutral and Gender just parenting.
2. Address and counsel regarding issues prevalent in Teenagers and Adolescent population.
3. Provide relationship counselling and mediation.
4. Counselling to Victims of Domestic/Sexual Violence.

Scope

The Scope of collaboration as a Training Partner with PANDIT NEKI RAM SHARMA GOVT. COLLEGE, ROHTAK in this Memorandum of Understanding includes the following categories:

- a. Provide the internship /volunteer programme for shortlisted candidates to the College students during and after the completion of their courses as per the requirements.
- b. Provide the soft skills training to female students of the college.
- c. Organizing/ participation in Joint seminars, conferences, workshops etc.
- d. Promoting such other activities/programs as mutually agreed from time to time.

3. Commencement, renewal, termination and amendment

This MOU will come into force upon affixing of the signatures of the representatives of the both organizations and will remain in effect for five (5) years starting from 17 September, 2024 to 16 September 2029. This MOU will be

renewed upon its expiry, as per mutual agreement of both organizations. If either organization wishes to terminate the MOU at the end of the five years period or in between the period of five years, it must notify the other organization not less than six months prior to the expiry of the MOU.

The event of termination will not affect participants from completing their activities at the host party already initiated or ongoing unless otherwise mutually agreed. This MoU, its 5 renewal and the actions taken under it will be reviewed at any-time.

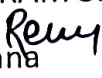
Modifications to MoU will be made by mutual consent and any amendment or extension to the MoU will be formalized by the exchange of letters and or emails between the two organizations.

4. Coordinators:

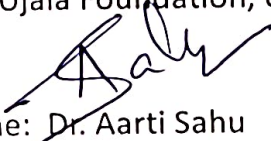

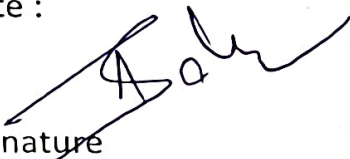
